COURTHOUSE

Mayor and Council met for a Council meeting December 6, 2012 at the Courthouse with Mayor Wayne Bullard presiding.

The Mayor asked if any questions or corrections regarding the meeting minutes. None noted. A motion was made by Mayor Pro Tem Cain to accept the minutes as read which was seconded by Councilmember Clendenin. Mayor Pro Tem Cain, Councilmember Clendenin, Councilmember Benjamin and Councilmember Adams voted in favor of the motion.

PUBLIC HEARINGS:

A.) HA-2012-02 Variance Request by Allen Crump (P&ZA)

Tracey Tolley of P&ZA stated that the variance request was to put up an LED sign at 1305 Ga. Hwy 125. This size of sign would be 68 square foot by 34 square foot. The LED would be in the gateway overlay to change out gas prices. She stated the planning commission could not recommend the variance cut that if Mayor and Council decide to approve that they would like to have considerations. 1. Board approved as shown size 2. Gas prices only change one time per day. City Manager Sumner then stated that the vote was 6-2 with Ted Raker making the motion to deny. The Mayor then asked if anyone had any questions. The Mayor

asked if anyone was wishing to speak in favor of the variance. Allen Crump of 4844 Bridgestone Road who is the sign contractor stated that the new LED sign is now a fad in the gas business. He stated that to change the old sign fonts was hazardous ordeal. He stated that the gas stations want to be competitive and wishes to have Mayor and Council vote in favor of the sign. The Mayor then asked if anyone wished to speak against the variance request. None noted. IT was then stated that the sign amendment already have temp basis due to DOT overpass ramps. A motion to accept variance request HA-2012-2 with conditions stated was made by Councilmember Benjamin which was seconded by Mayor Pro Tem Cain. Councilmember Adams and Councilmember Clendenin voted against the motion. Mayor Pro Tem Cain and Councilmember Benjamin voted in favor of motion. Mayor Wayne Bullard voted in favor of motion breaking the tie.

B.) FY 12 Budget Amendments (City Manager)

City Manager Sumner stated this standard procedure. He stated that last year on amendments. This year there is a change in Revenue due to traffic enforcement unit and extra expenditures. Sumner stated that as per code the budget has been advertised and copies are available at City Hall. No request from citizens. He then stated there are copies in folder. The Mayor asked if anyone had any questions. None noted. The Mayor asked if anyone wished to speak in favor of budget. None noted. The Mayor then asked if anyone was wishing to speak against. None noted. A motion was made by Councilmember Clendenin to accept the FY12 Budget Amendments which were seconded by Councilmember Benjamin. Mayor Pro Tem Cain, Councilmember Clendenin, Councilmember Benjamin and Council member Adams voted in favor of the motion.

REVIEW OF BILLS/BUDGET OVERAGES:

The Mayor asked if anyone had any questions. City Manager Sumner stated in regards to the question from work session the item under contributions was a coding error; revenue cannot be coded to expenditure. He stated that a donation was received in the amount of \$1000.00 for furniture for the EMS building and this was the purpose of the expenditure. Councilmember Adams had a question regarding the amount of the landfill charges and inert debris charges. City Manager Sumner stated was not sure but would check on it and let them all know. She then asked if we have anyone in Leadership Lowndes course, Sumner stated no. Councilmember Adams made a motion to pay the bills which was seconded by Councilmember Benjamin. Mayor Pro Tem Cain, Councilmember Benjamin, Councilmember Adams and Councilmember Clendenin voted in favor of motion to pay the bills.

DISCUSSIONS:

RICOH IT REPORT

City Manager Sumner stated that the IT provider was present at Monday night work session and that one thing came out of meting that everyone wanted to go to paperless agenda and that we need some form of interface. He stated that RICOH had talked to us about hardware unit and that the sales representative could not attend meeting tonight but that he would attend the meeting on January 7th. Sumner stated that we do have internet service now at Courthouse.

ODOM BUILDING

Mayor Bullard stated that everything is on schedule now and that the building should be empty first of year.

The Mayor stated it will be the first of the year.
